period of 1 January 2013 to 1 May 2013 to convert from US dollars to Canadian dollars. Progistix Solutions Inc., a company owned and operated by Canada Post, performs the Warehouse and Distribution (W&D) functions for modems shipped to Internet service providers (ISPs) for bulk orders or directly to the ISP's end-users. This cost, expressed in dollars, applies to each modem. The modem and the W&D are subject to applicable taxes but are shown excluding taxes in the table. As the modem is sold 'outright' to the ISP, the applicable taxes are recoverable and do not represent a cost to the Companies.

The Companies note that the figures shown in the table above do not account for other costs incurred by the Companies such as processing the order from the ISP as well as billing and collecting the fees from the ISP.

The Sagemcom modem is made available by the Companies to ISPs at a price of \$110 plus tax, per modem. As can be seen, this price is reasonable given the costs incurred by Companies.
